California Wine Country Journey -A Week of Tasting, Exploring, & Friendship

Our California Wine Trip was everything we dreamed of and more! With the expert guidance of Mike Hibbard from Destination Sonoma, our group experienced nonstop flights, extraordinary wines and champagnes, delicious food, breathtaking landscapes, and daily sunshine that warmed our spirits. Each day brought new delights, laughter, and cherished memories.

Saturday, we landed early, eager to start our journey. Lunch at Sam's Anchor Café in Tiburon offered panoramic views of the bay and the iconic Golden Gate Bridge—picture-perfect for our first meal in California! We made a quick stop in Healdsburg before arriving at Dry Creek mid-afternoon, personally greeted by Mike and his over-the-top Welcome Party spread of shrimp, smoked salmon and homemade trout dip and of course wine.

Sunday's first winery visit started at the stunning Kunde Winery. Sonaya welcomed us with a glass of wine before leading us on a cave tour filled with oak barrels. Her passion for winemaking was infectious. Afterwards, we strolled through historic Sonoma Square. The day's highlight came at St. Francis Winery, where we enjoyed a five-star wine and food pairing. Voted best wine and tasting room for two years running, it was indeed "over the top." Special thanks to Cindy Mintus, who snagged the recipe for their unforgettable tater tots—a little crispy magic!

Monday morning began at Stuhlmeyer Winery, where Barbara and Brenda, our hosts, were delightful and kept bringing out delicious wines. Oliver's Deli sandwiches tasted even better, surrounded by vineyard views and good company. Reluctantly, we moved on to Saini Winery, where Laura Saini shared the heartfelt history of her family's winemaking.

Tuesday, we experienced the pure magic of Armstrong Woods. We wandered beneath towering redwoods, sunlight dappling through ancient branches, hushed in awe. The air was cool, damp, and tinged with pine—a cathedral of nature. My personal highlight was hugging a majestic redwood. Next, Korbel Cellars dazzled us with a reserve champagne tasting—tiny bubbles, big flavors. Lunch at Russian River Café was delightfully rustic, the owner's story of friendship with Guy Fieri added more flavor. Our final stop at Balletto Winery continued our streak of tastings, each one distinct and memorable.

Wednesday, we set out for the Pacific coast, stopping at Bodega Head, where the ocean crashed below raw and beautiful. From there some of us hiked to the UC Davis Marine Bio Research Lab, where we learned about ocean life and their efforts to save anemones. We savored another fabulous picnic lunch of famous clam chowder from Spud Point Crab on the rocks at Goat Rock, gazing out at the foggy ocean. Back at the hotel, an unexpected double-booking changed our cooking class plans, but thanks to Denise Malovich, we rallied for pizza in Santa Rosa instead. Her quick thinking and calm kept our spirits high. Mike soon rebooked our Sur La Table class for Friday—no adventure lost!

Thursday at Merriam Winery, Pete and his son Evan welcomed us to their newly remodeled patio. We had much in common, both were skiers and Evan's Springer Spaniel was from East Palestine. More great wine. We continued to Yountville in Napa Valley and then dined at Gott's Farm Market in St. Helena, finishing with creamy ice cream. Thanks, Jeannie Shimek, for the stellar recommendation!

Friday was a foodie's dream. We headed to Petaluma Gap to tour Nicasio Cheese farm, savoring farm-fresh, all-organic samples. Next was McEvoy Ranch, where the taste of organic olive oil was a true farm-to-table experience. But the day's highlight was our Sur La Table cooking class: steak with cognac mushroom sauce, tomato and peach salad, carrot tart, and lemon pound cake with berries. Laughter echoed as we rolled dough and tasted our creations. Our final evening included a ski club tradition, a "liquidation party," where we raised glasses to new friendships and began plotting our next wine adventure.

Saturday, we departed before dawn. Home beckoned.

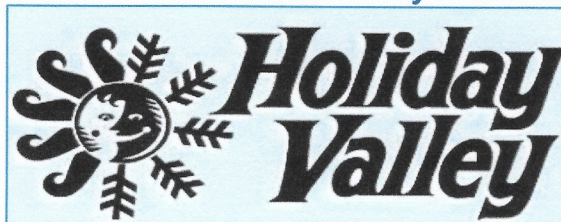
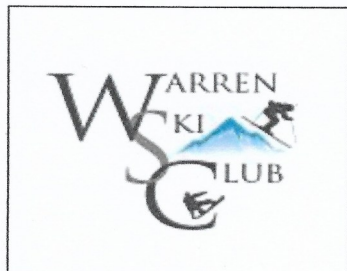
Important Information on Membership

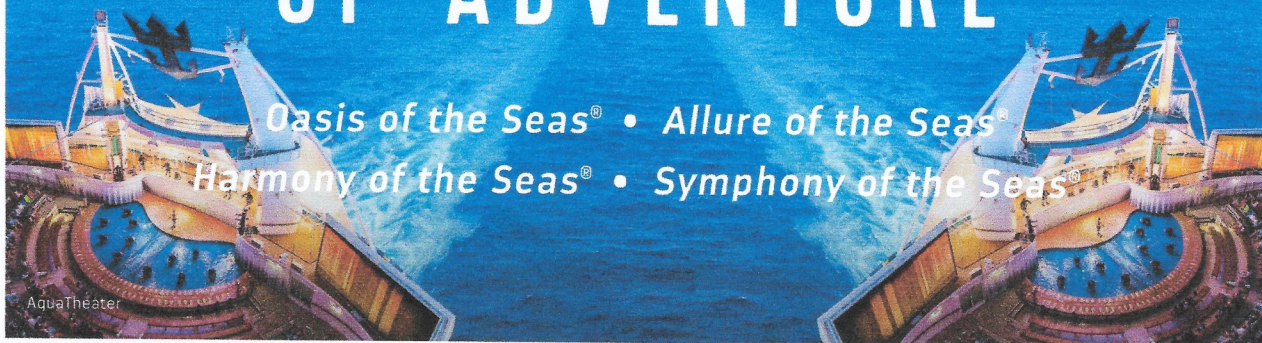

WARREN SKI CLUB TRIP AND EVENT AGREEMENT (Revised 7/25)

A. CANCELLATION AND/OR CHANGES. The Warren Ski Club (Club) reserves the right to withdraw from an event or trip or make changes to the published event or trip if conditions warrant. The Club reserves the right to refuse to accept or retain any person as a participant in an event or trip at any time

B. RESPONSIBILITY. The Club is acting as an agent for all participants and shall not be liable for any delay or inconvenience during any activity or trip, any loss of or damage to property, personal injury, death, accident, or illness during an event or trip. Participation and all activities are at the participant's own risk.

C. REFUNDS. If a Participant cancels after a payment has been made, the Participant must notify the Trip Leader or Host in writing and receive written acknowledgement of said cancellation to receive any possible reimbursement. If a Participant cancels and the Club can fill your spot, you may be refunded any amounts the club is reimbursed less a club handling fee. You will be charged a \$50 handling fee for trips costing less than \$1,000 and \$100 handling fee for trips or events costing more than \$1000.

D. LAND ONLY PACKAGES OR SEPARATE TRAVEL PLANS. If a Participant chooses to travel separately from the club's planned trip, the Participant understands that the Club is not responsible if the group flight or land transportation changes.

E. MISSED TRANSPORTATION. If a Participant misses or does not use the club's group transportation, it is the Participant's responsibility to find and pay for replacement air and/or ground transportation. The Participant will also be responsible for any additional costs to the club.

F. ADDITIONAL FEES. If a trip package price increases due to taxes, unknown costs, or foreign rate of exchange, the Club reserves the right to modify the trip cost and charge the Participant an additional fee.

G. MINORS. A minor's trip registration and trip and event agreement must be signed by their parent or guardian who is also accompanying the minor. The Club reserves the right to limit or not allow minors to participate in certain trips or activities.

H. TRIP INSURANCE. The Club does not provide trip insurance but strongly encourages Participants to purchase it from any insurance company of Participant's choice.

I. FORCE MAJEURE. The Club is not liable to the Participant or Participant's family for any resulting damages from acts of God, fire, explosions, adverse weather conditions, floods, earthquakes, terrorism, riots, civil commotions, wars, strikes, work stoppages or slowdowns, acts of government, lack of power, or non-performance or delays by suppliers or other conditions not under the Club's control.
