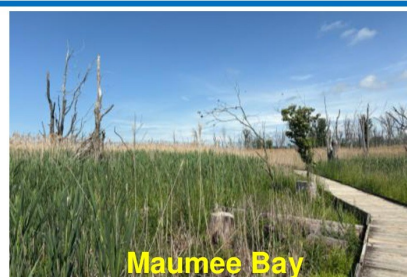
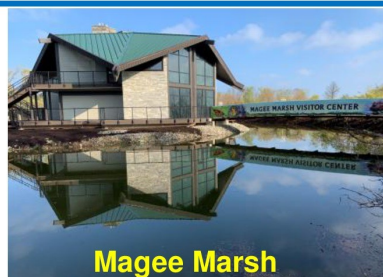
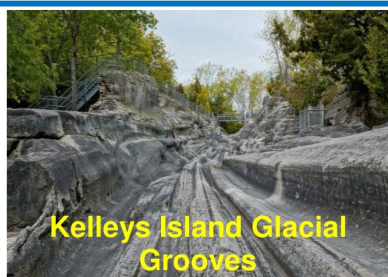
WHAT ARE THESE PLACES WE'RE TRAVELING TO?

* **Kelleys Island Glacial Grooves**: The glacial grooves are 400 feet long, 35 feet wide, and up to 15 feet deep. They were created by the slow movement of the massive glacier that created the Great Lakes and Lake Erie Islands. This National Natural Landmark is the largest and best accessible example of this geological phenomenon anywhere in the world!

* **Marblehead Lighthouse State Park**: The Marblehead Lighthouse is one of Lake Erie's best known and most-photographed landmarks. It is the oldest lighthouse in continuous operation on the Great Lakes.

* **Magee Marsh**: The Lake Erie marshes gained fame during the late 1800s as some of the best waterfowl hunting areas in the United States. Today, the region still supports some of the most intensively developed and managed waterfowling in the Midwest.

* **Maumee Bay State Park**: The landscape here is a unique environment created by the convergence of the land and Lake Erie. A resort lodge, cabins, and golf course are nestled among scenic meadows, wet woods, and lush marshes. More than 300 bird species have been observed here.

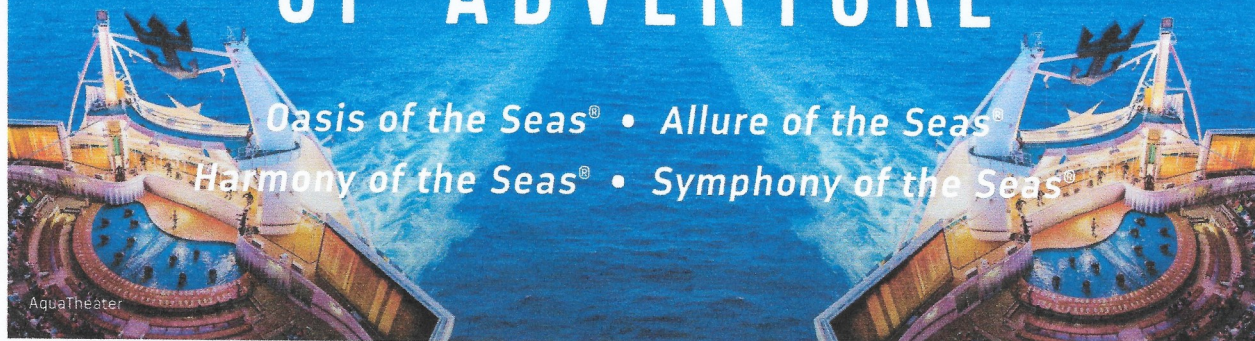
