We are using Ski Group for Winter Park and Snowmass, and Sports America for Big Sky. Call me if you need help choosing the best pass or option. Note: IKON passes are non-transferable and non-refundable, so please consider pass protection and/or injury insurance. This insurance must be purchased directly from Alterra at 1-888-365-IKON within 24 hours of purchase.

Pass Information

Our 2026-27 ski locations are all covered by the IKON Base Pass for the time we will be at the locations. If you want unlimited days and all 4 Aspen area resorts you must purchase the Full IKON pass. The price of the passes is fluid, and at the time of publication they are IKON Base: \$1019, IKON Full: \$1449.
